Total balance due must be paid in full by August 31st, 2010. If payment is not received by the due date, the child will be placed on a waiting list and may not begin camp until balance is paid.

Important Information for New Campers:

Have your client/student schedule an interview as early as possible, and no later than May 1st. We strongly recommend that you follow up with families or contact us directly to ensure that an interview is scheduled. Interviews can occur in Reading, Danvers or Lexington. **Please note that a scheduled interview does not guarantee a placement in camp.** The purpose of the interview is to ascertain individual needs and assist in determining the most appropriate group placement. Interviews are not necessary for children who have attended our programs in the last year.

Important Information for All Campers:

1. A completed and signed application must be received before child can be considered for placement.
2. In order for the child to attend camp once accepted, health and immunization forms must be submitted.

I authorize Camp Triumph staff to transport my child to the pool or to field trips within approximately a 30 minute proximity of camp. I agree to allow my child to go on camp-sponsored field trips. I will notify the camp if I do not want my child to go on any field trips. I give Camp Triumph permission to videotape and/or photograph my child. Videotapes and photographs will be for internal use only and will not be used for any promotion of the camp unless specifically authorized. While some schools or agencies may choose to fund Camp Triumph, I understand that I am ultimately financially responsible for all Camp Triumph fees.
